PARTIES: The Lake Jeanette Association and Lake Jeanette Marina are "Licensor" herein and the undersigned are hereinafter "Licensee". **RENTAL**: This Agreement is for the exclusive use of rack space #\_\_\_\_\_\_. The charge for the exclusive use of the space shall be \$\_\_\_\_\_ for the Term. The charge for the Term shall be paid in full upon execution of this Agreement. SURRENDER OF RACK SPACE AND PERSONAL PROPERTY: Licensee understands that Licensee will be invoiced to renew this Agreement 30 days prior to the end of the Term. If the invoice for renewal is not paid by the expiration of the ending Term, or this Agreement is terminated by Licensor as set forth below, the Licensee will surrender possession of the rack space and shall remove any personal property from the rack space within ten (10) days of the expiration of the ending Term or termination date. In the event Licensee fails to remove their property from the rack space area after a term expires and is not renewed, or after termination, the Licensor shall send a Notice to Vacate to Licensee demanding removal of all personal property within ten (10) days of the date of the Notice to Vacate.
